Our pledge: We recognize that nothing we print matters more to the people who are touched by it than an obituary. Because of this, we consider the careful handling of obituary content to be of the highest priority.

Our policy: Families can say as much or as little as they would like about a loved one in a paid obituary, and in the words they choose. Aside from requiring that obituaries be in good taste and factually accurate, we edit paid content only for style, spelling, grammar and punctuation. There is no charge for a basic obituary that conveys only the fact of someone's death and service information, for a death announcement that will be followed later by a paid obituary, or for an announcement of services held substantially after a person's death. Examples of these free items appear to the right.

Our pricing: We charge a fee of \$100 for a standard obituary of up to 300 words. Families may include a photograph and, in the case of veterans, a flag at no extra cost. (See samples) For longer obituaries, we charge an additional \$10 for every 25 words. There is also a \$10 service fee for obituaries that are faxed, in light of our need to retype them.

Our deadline is 5 p.m. daily.
